

## **Rules for All MWCR Sponsored Events**

- Children are the responsibility of the adults who brought them. They are to remain closely supervised at all times.
- No intact dogs over the age of 6 months are allowed. Only spayed or neutered animals.
- Puppies under the age of 6 months are not allowed to play in the adult dog off leash area.
- Only dogs off leash are allowed in the off leash area.
- Fresh water is to be provided at all times.
- No food (dog or human) is allowed in the off leash area.
- No toys are allowed in the off leash area.
- Dogs are to be leashed at all times unless in the off leash area.
- Dogs are to be up to date with all vaccinations.
- Dogs that are sick or not feeling good should be left home.
- In order to participate in the Event, a signed liability waiver must be signed and in possession of the Event Lead
- For all events, foster dogs are considered the sole responsibility of the handler (foster family) and are managed as such under this agreement.
